1. Hamburg Twp. Aquatic Weed Control SAD - 1st Public Hearing

A call was made to open the hearing to the public for comment on the Hamburg Township Aquatic Weed Control SAD.

Larry Gauthier, 5099 Lisch Drive, stated support for the assessment with concern of the exclusion of upstream Huron River and Ore Lake from the plan.

Dan Stahl, 4379 Cornwell Lane, commented to encourage residents in the district to not fertilize their lawn.

Jeff Rey, 10660 Bob White Beach, stated support for the assessment and the need to harvest the weeds as well.

Jacqueline Harvey, 10029 Pearson Drive, stated support for the assessment with the concern of weed control on Girard and the weeds floating back onto their shore. Also, requested a clarification if the SAD will be treating all aquatic or just invasion weeds.

Charlotte Jones, 10047 Pearson Drive, stated support for the SAD with concern for the residences on the North and West side of Zukey Lake having a collection of weeds in the shallow areas which has been overlooked by Washtenaw County.

Andy Grendze, 5065 Girard, stated support for the weed control with concern of the current application process being too far from the shore line providing no relief from the weeds at the shoreline.

John Greko, 5206 Gallagher Blvd, stated support for the weed control with the concern for the shallow areas not being currently treated close enough and the harvester is not helping the shorelines on the lakes.

Charles Kronk, 5297 Redding Dr, stated he would like residents have the a contact for the weed control company and would like a Board Member liaison for the SAD.

Dennis Ray, 4293 Shoreview Lane, the Northshore properties are not being treated close enough to the shoreline.

Steve Boston, 9658 Zukey Drive, cost clarification and looking for more information on how the process of weed control is done.

John Schneider, 10875 Lakepoint Drive, expressed concern for the chemicals mixing in the entire lake and mixing in with the animal/plant environments.
