Re: New HVAC Unit- Township Hall

I request approval to replace one of the AC/Furnace units at Township Hall. The air conditioning on this unit currently needs nearly \$1,000 worth of repairs for a short-term fix. This is not economical, especially since the unit is twenty-five years old. I have obtained two quotes for replacement and I recommend ordering the new unit from Lakeside Service for a total price of \$11,303.64, which is roughly \$1,000 lower than the other quote.

We anticipated replacing an AC/Furnace unit this year at Township Hall, but we did not include enough for the full amount in the budget. However, we will make up the difference through building reserves/and or savings from other line items in the Buildings and Grounds budget.
