11. Community Service Day – Lakelands Trail Clean-Up – April 24, 2026 – 8AM-Noon

Motion made by Negri, Seconded by Daniels, To approve the scheduling and coordinating of a Community Service Day coinciding with Earth Day (April 24, 2026) to clean up the Mike Levine Lakelands Trail Linear State Park, along with our neighboring townships, Putnam and Green Oak. To direct Henneman to coordinate with Kensington Woods Schools who have offered some man power for this event. Expected budget not to exceed \$1,000 and should include payroll for key

staff. Proposing to make this an annual event, providing each Township coordinates and funds efforts for their own portion of the trail.
