

**TOWNSHIP OF HAMBURG  
ADJUSTMENT TO PAY FOR THE TOWNSHIP CLERK**

At a regular meeting of the Township Board of the Township of Hamburg, Livingston County, State of Michigan, held at the Hamburg Township Board Room on Tuesday, June 6 2023, beginning at 2:30 p.m., Eastern Standard Time, there were

**RESOLUTION**

**WHEREAS**, Hamburg Township commissioned a salary study with the purpose of bringing our salaries in line with comparable communities; and

**WHEREAS**, the study, completed in the spring of 2021, revealed that at that time, the salaries for Hamburg's 3 executive elected positions (Supervisor, Clerk and Treasurer) were lower than the salaries for elected officials in comparable communities and recommended that these salaries be increased by 10%; and

**WHEREAS**, the U S Bureau of Labor Statistics compensation cost increase for state and local government workers increased by 4.9% from April of 2022 to March of 2023--since the completion of the salary survey; and

**WHEREAS**, the Township Clerk, since May of 2009 has not had an Administrative Assistant, thereby saving the township hundreds of thousands of dollars in wages and benefits in the ensuing thirteen years;

**WHEREAS**, the Township Clerk is available to the elected, staff and residents of the township evenings and weekends by cell phone, email and often by meeting in person with residents and staff after hours;

**NOW THEREFORE, BE IT RESOLVED**, that the Township of Hamburg hereby increases the salary of the Clerk by 5%, to bring it more in line with the median. The increase will bring the Clerks' annual salary from \$80,452.74 to \$84,475.38 effective with the pay period beginning July 1, 2023.
