Be advised: Water tap fee discounts shall apply to cash-up front purchases only. Discounts will not be applied to any tap fees that are to be financed through a Township bond sale or Contract SAD Agreement.

SECTION (2) COMMODITY USE AND CAPITAL IMPROVEMENT RATES & CHARGES

USER CHARGES (per REU, per Quarter)

QUARTERLY WATER
RATES AND CHARGES:

Water Use Commodity Rate:	<u>\$6.10 per 1,000 gallons*</u>
Capital Improvement Charge:	<u>\$3.00 per 1,000 gallons*</u>

* Water commodity rates and charges set per LCWA Resolution No. 23-003 effective as of January 1, 2024. Rates and charges shall be determined by the LCWA on an annual basis.

NOTES: Effective as of January 1, 2022, there will be a \$5.25 per quarter REU Capital Replenishment Charge on all developed/non-vacant parcels assigned REU's to be billed annually in April.

For all properties located within the existing water service S.A.D. or those wishing to extend the municipal water service area the connection (tap) fee is now \$7,500.00 per REU. The Township Board hereby reserves the right to negotiate tap pricing for those entities, projects, etc. desiring to purchase larger quantities of water taps.

on all developed / non-vacant parcels with assigned REU's to be billed annually in April.
