That the applicants meet with the Public Safety Dept. at a time agreeable to the Public Safety Director at least two weeks before the event to finalize the plan. That it be limited to 150 vendors, including food trucks, for a maximum of 150 participants. That the event be held on the east side in the area previously designated for the Fun Fest. That should inclement weather exist, that the participants have to meet with the Director of Public Safety the day before the event to assess parking.**
