Requested Action

- Motion to approve the outfitting of two 2023 Dodge Chargers at Cruisers of Brighton at a total cost of \$29,910.

Background

The Township Board authorized the department on February 4, 2025 to purchase two 2023 Dodge Chargers at a discounted price from a dealership in Ohio. These new vehicles were originally scheduled to be purchased in the 25/26 fiscal year. At the time of the Board's approval, it was decided that the outfitting of the vehicles wouldn't occur until the new fiscal year (FY 25/26). Both vehicles can be outfitted at Cruisers of Brighton at a cost of \$14,955 each for a total cost of \$29,910.
