VILLAGE OF HARRISON POLICE SERVICES CONTRACT — ADDENDUM 1

ADDENDUM 1 "Addendum" made this _____ day of May, 2025 by and between the VILLAGE OF HARRISON, a municipal corporation, with business offices located at W5298 Hwy 114, Menasha, Wisconsin, 54952, in Calumet County, Wisconsin (hereinafter referred to as "Village"), and CALUMET COUNTY, a municipal corporation of the State of Wisconsin (hereinafter referred to as "County") with the Sheriff's Office located at 206 Court Street, Chilton, Wisconsin 53014. The entities individually may be referred to as "party" or collectively may be referred to as "parties."

RECITALS

WHEREAS, the Village is required to provide its own police protection services but does not have its own police department and desires to contract with the County for the furnishing of such services under the provisions of Wis. Stat. §61.65, and other provisions of law; and,

WHEREAS, the County is willing to provide the Village with the desired services as the County does now furnish police protection services throughout Calumet County, Wisconsin; and,

WHEREAS, an increase in the amount of services has been requested by the Village for the purpose of supervision of its contracted deputies.

NOW, THEREFORE, IN CONSIDERATION OF the mutual covenants and promises set forth, and other good and valuable consideration, the receipt of which is acknowledged by both parties, the parties agree as follows:

- A. **RECITALS.** The above recitals are true, correct, and incorporated here by reference.
- B. **COMPENSATION.** The Village is responsible for the actual costs incurred by the County. The Village shall pay to the Calumet County Treasurer monthly rate-based costs for services provided January November. The monthly bill in December will reconcile the actual costs with the amounts paid and bill accordingly.
- C. ADDITION OF SUPERVISORY OFFICER. In 2025 the County will provide a dedicated supervisory position to the Village. The rank of the supervisory position will be Patrol Sergeant. This position is in addition to the staffing terms in section F (1). The Patrol Sergeant will report to and work out of the Village office. The Patrol Sergeant shall normally work a 2,080 hour, Monday Friday work cycle. The workdays and hours will be flexible to fit the needs of the Village. The Patrol Sergeant will work cooperatively with the Village Manager and staff. The Patrol Sergeant will attend Village Board meetings and provide monthly updates on activity in the Village. The Patrol Sergeant will report to the Patrol Lieutenant at the Sheriff's Office.
