After the Cottonwood Creek project was completed, the Village and residents rejected a follow-up proposal to incur the additional expense and disruptions for a subsequent storm sewer project.

### Our Meeting Notes (3/10/25):

- WE DO NOT WANT POOLING WATER IN OUR DITCHES
  Residents feel it's unacceptable to live with unsafe, unsanitary conditions
- We do want assurance and/or clarification that this initiative is exempt from the following:

"The Village Board approved a policy that stops the Village from giving financial help to residential development. People can submit residential projects, but the village won't provide any financial aid for them." (Source: Facebook group by Village of Harrison)

- We want a collaborative solution between the village and residents
  - Village Staff:
    - Review results of the most recent elevation survey completed by McMahon
    - Offer various solutions, explain the pros /cons of each
    - Help concerned residents align on plans that will address the overall concern of pooling water in ditches
    - If a resident chooses to do nothing, then help neighbors understand the cadence for which the village will maintain that ditch at that property owners expense
    - Residents: Work with neighbors
      - At a minimum, solutions require alignment between 3 adjacent neighbors
- This collaborative initiative with 6-7 concerned residents, may serve as a role model or a standard that the Village Staff can use to help others in our community who are facing similar challenges.
