Dear Village of Harrison,

We welcome the opportunity to submit a proposal to acquire lots #1 & #2 for a combined 2.303 acres located within the Crossroads Business Park, Village of Harrison WI as shown on the Crossroads Business Park Survey Map below. We are currently working with Keller, Inc in the design of our future building. We are currently being represented by Coldwell Banker Commercial Real Estate Group.


