Title: President's Appointments to Boards and Commissions

Issue:

Does the Village Board wish to confirm the appointments to the boards and commissions for the new terms?

Background and Additional Information:

Besides the Plan Commission, re-appointments are needed for: one (1) Fire Commissioner, one (1) Weed Commissioner, and two (2) Zoning Board of Appeals seats.

There is also a vacancy on the Zoning Board of Appeals for an unexpired term caused by a recent resignation. Staff is recruiting a candidate to fill this position soon.

Plan Commission – Possible Scenarios

- In January 2025, the Board amended the Plan Commission membership by transferring one of the two Trustee Seats to a Citizen Seat, therefore, there needs to be three (3) Citizen Seat appointments: <u>2 original</u> expiring citizen terms + 1 <u>transferred trustee</u> seat.
- If the Board decides tonight to amend the Plan Commission membership further, by transferring the President's Seat to a Citizen Seat and limiting the remaining Trustee Seat to a one-year term, then there needs to be four (4) Citizen Seat appointments: <u>2 original</u> expiring citizen terms + 1 <u>transferred trustee</u> seat + 1 <u>transferred president</u> seat, and the remaining <u>Trustee Seat for the new one-year term</u>.
