



RESOLUTION TO APPROVE DWSRF 7777—01 CONTRACT A & B MODIFICATION

At a Regular Business meeting of the City of Hartford Commission, located at 19 West Main Street and called to order by Mayor Jane M. Danger on June 18, 2026 at 6:00p.m.

The following resolution was offered:

WHEREAS, Wightman has presented proposed modifications to DWSRF Project No. 7777-01, Contract A with Compton, Inc. and Contract B with Kalin Construction; and

WHEREAS, Contract A (Compton, Inc.) Modification No. 2 includes additional pay items necessary to cover new 2-inch water service installations, resulting in a net contract increase of \$78,700.00; and

WHEREAS, Contract B (Kalin Construction) Modification No. 1 changes the water service pipe material on the private side from copper to high-density polyethylene (HDPE) to ensure consistency with Contracts A and C; and

WHEREAS, Contract B Modification No. 1 also provides for the use of a larger meter pit cover than originally specified in the project plans and specifications, resulting in an additional cost of \$200.00 per meter pit cover; and

WHEREAS, Contract B Modification No. 1 further provides for the use of tapping saddles in lieu of cutting wyes into existing sanitary sewer mains where only lateral replacements are planned, consistent with modifications made to Contract C; and

WHEREAS, in areas where new sanitary sewer mains are being installed, sanitary sewer laterals will continue to be installed using new PVC wyes; and

WHEREAS, the changes to Contract B result in a net contract increase of \$28,230.00.

NOW THEREFORE BE IT RESOLVED, that the City Commission of the City of Hartford hereby approves DWSRF Project No. 7777-01 Contract A Modification No. 2 with Compton, Inc. and Contract B Modification No. 1 with Kalin Construction; and

BE IT FURTHER RESOLVED, that the City Manager is authorized to execute all agreements, change orders, and related documents necessary to implement these modifications.
