RESOLUTION TO APPROVE CONTRACT 222324-C MODIFICATION

At a Special Business meeting of the City of Hartford Commission, located at 19 West Main Street and called to order by Mayor Jane M. Danger on June 16, 2026 at 4:30p.m.

The following resolution was offered:

Moved by Commissioner _____ and supported by Commissioner _____.

WHEREAS, during a progress meeting the contractor and engineer observed that the existing sanitary sewer laterals on Marion Ave were in poor condition; and

WHEREAS, most of the existing sanitary sewer laterals have been identified as Orangeburg pipe, which is considered an unsuitable material due to its age and condition; and

WHEREAS, DPW Superintendent Ricks has reported that several Marion Avenue residents have experienced sewer backups; and

WHEREAS, Wightman has presented proposed modifications to Contract 222324-C, with Krohn Excavating, LLC; and

WHEREAS, the estimated cost to replace all sanitary sewer laterals on Marion Avenue is as follows:

Item	Quantity	Unit Cost	Total
8-inch x 6-inch Sanitary Wye	29 each	\$1,000.00	\$29,000.00
6-inch Sanitary Sewer Lead	870 linear feet	\$41.00 per foot	\$35,670.00

Estimated Additional Project Cost: \$64,670; and

WHEREAS, the proposed modifications will result in a net increase to Contract 222324-C in an amount not to exceed \$65,000.00.

NOW THEREFORE BE IT RESOLVED, that the City Commission of the City of Hartford hereby approves Contract 222324-C Modification with Krohn Excavating, LLC in an amount not to exceed \$65,000; and

BE IT FURTHER RESOLVED, that the City Manager is authorized to execute all agreements, change orders, and other documents necessary to implement these modifications.
