Michigan Public Service Commission (Commission) will hold a pre-hearing to hear Consumers Energy Company's (Consumers Energy) May 31, 2023 petition requesting the Commission to: 1) determine that Consumers Energy's Energy Waste Reduction (EWR) plan reconciliation is reasonable and it and meets all relevant requirements under Act 295; 2) approve the plan of a financial performance incentive payment for both the natural gas sector EWR plan, the collection of which is to be completed by December 31, in order to comply with the requirements of ASC 980-605-25; 3) approve the surcharge mechanism as proposed by Consumers Energy; 4) approve the excess totaling 177,991 MWh into Renewable Energy Credits in 2022 for meeting Consumers Energy's renewable energy requirements under Act 205) grant Consumers Energy other and further relief.

Comments filed in this case shall be submitted electronically through the Commission's E-Dockets website at: michigan.gov/mpscedockets. Comments and instructions for filing can be found in the User Manual on the E-Dockets help page. Persons wishing to intervene and become a party to the case shall electronically petition to intervene with this Commission by July 5, 2023. (Interested persons may elect to file using the traditional paper format.) The proof of service shall indicate service upon Consumers Energy Company's Legal Department – Regulatory Group, One Energy Plaza, Jackson, MI 49201. A rehearing is scheduled to be held remotely by video conference or teleconference. Persons filing a petition to intervene will be advised of the process to participate in the hearing.

Persons wishing to participate without intervention under Mich Admin Code, R 413 (Rule 413), or file a public comment, may do so by filing a written comment in this docket.
