





Business Checks and Foot Patrols: These checks are a proactive approach to assure safety, security, and crime prevention at all local businesses. Officers will speak directly to the business owner(s) or staff, providing the opportunity to discuss issues or concerns they may have. Officers will conduct physical checks when the business is closed to ensure that all doors and windows are locked. Officers will also conduct foot patrols in residential and commercial areas allowing community members to engage in discussion while simultaneously preventing crime. Lastly, enhanced patrols are conducted by officers in specific areas to deter criminal activity or traffic violations.

Request for Outside Agencies to Assist the Haymarket Police Department in corporate limits: 4





Time spent by outside agencies on calls for service as primary responders: Approximately 3 hours










































## **Status of Current Projects/Events:**

- Please subscribe to the Town of Haymarket's Emergency Management notification system. Text the word "Haymarket" to 888777 to subscribe.
- The VLEPSC Accreditation Team arrived on November 16, 2025. Members lodged at the Hilton Garden Inn. The assessment began on November 17, 2025 at 8:30am with a static display of police vehicles and equipment. At that time, they conducted interviews with Sgt. Finley and MPO Galbreath. This included guestions about departmental policies and the equipment. Directly after the assessment, the team was provided with a departmental tour by Chief Sibert. The assessment then moved into the upstairs conference room and began reviewing accreditation standard folders. During the afternoon, two team members inspected the department's evidence and property room with Lt. Davis while the 3<sup>rd</sup> team member conducted a ride along with Sgt. Finley. The team completed day 1 at 5pm and had dinner with Mayor Tracy Lynn Pater, Town Manager Emily Kyriazi, and Chief Allen Sibert. Dinner was completed at 8:30pm. The assessment team reconvened at 8am on November 18, 2025. They completed file reviews at approximately 5pm. At that time, they held an exit interview with Chief Sibert. The team was very impressed with the department, the staff, and the VLEPSC standard folders. Chief Sibert and staff have been instructed to attend the next VLEPSC meeting on December 4, 2025 in Charlottesville Virginia. At that time, the assessment team leader, Captain Jacob Siddons, will present the team's findings to the VLEPSC Board of Directors. Chief Sibert will answer any questions or inquiries that board members may have. At that time, the Board will vote on the Haymarket Police Department's Accreditation Status.
- HPD partnered with the Prince William County Police Department, DEA, UVA Health, and Caring Senior Service for National Drug Take Back Day. Over 200 pounds of unused and unneeded drugs were turned in for destruction.
- Stakeholders held a Senior Summit Meeting on November 14, 2025. Plans are proceeding for the April 2026 event.
- Reimbursement in the amount of \$10,000, from the VSP HEAT Grant has been received.
- Officers Anderson and Culbertson attended the Brooks Heating and Air Truck or Treat on October 24, 2025 located at the Trouvaille Brewing Company.
- Chief Sibert, Lt. Davis, Ofc. Coppage, MPO Galbreath, and Ofc. Culbertson took part in the annual departmental Halloween Candy Handout. All locations served several children.
- Lt. Davis and Ofc. Culbertson attended the Prince William County Police Department Trunk or Treat. Several thousand children attended the event which was held indoors due to the inclement weather.
- Officer Anderson and Officer Culbertson attended the 1<sup>st</sup> annual "Fair in the Square" event held at the Prince William County Courthouse. They were able to hand out departmental information along with traffic safety brochures. Several hundred attended the event.
- DMV Grant reimbursement requested was sent to DMV on November 2, 2025 in the amount of \$6,548.
- On November 3, 2025, Chief Sibert filed the Annual Officer Population report with the Virginia State Police, (Form SP278).
- On November 6, 2025, Chief Sibert corresponded with VDOT about the upcoming Christmas event on December 13, 2025.
- On November 13, 2025, Chief Sibert and MPO Galbreath completed the Virginia State Crime Commission's survey on the use of ALPR systems. This is complying with legislation passed during the 2025 General Assembly Session (Virginia Code § 2.2-5517).
