I was hoping you can assist me on the above file for the Hammond residence at 4203 Tranquility Drive. The FDEP permit includes the below activities which do not match the

dimensions provided on the Town submitted plans (see attached Town submitted plans). I want to make sure that these small discrepancies do not affect the validity of the applicant's FDEP permit. Kindly advise.

- FDEP: Install **135** linear feet of new seawall and seawall cap vs Town submitted plans which show **136'-6"**.
- FDEP: Install **425** sf concrete dock vs Town submitted plans which show **297.5** sf
