C. FY 2022 Employee Health Insurance Renewal - Finance Director Matthew Lalla

Chairperson Stern read the title into the record and referred to Finance Director Lalla.

Finance Director Lalla presented a PowerPoint presentation of the fiscal year 2022 employee health insurance renewal and addressed the board's questions about the Budget.

Chairperson Stern asked about the funds from the emergency response related to the COVID 19 pandemic. Town Manager Labadie explained how the Town would recalculate the money into the Town's budget and he discussed the timeline on which the Town would need to spend the funds.

D. Analysis of General Fund Balance – Vice Mayor Moore (This item was added to the agenda)

Chairperson Stern read the title into the record.

Vice Mayor Moore presented a PowerPoint presentation explaining the Analysis of General Fund Balance. She explained that the purpose was to obtain feedback. In addition, she provided a breakdown of the assigned versus unassigned fund balance. The proposal was to consider using the unassigned reserves to avoid the cost of financing the startup fees associated with the Fire Rescue Capital Investments.

Member Greenwald provided comments and stated that this item should be looked into.

Member Goldberg asked about the Towns flood insurance.

A. Discussion on Advisory Board Schedule – Member Greenwald (This item was added to the agenda)

Chairperson Stern referred this item to Member Greenwald.

Member Greenwald provided comments about the current Financial Advisory Board meeting schedule and the need to be more active in assisting the Town Commission with the Town's financial concerns.

Member Goldberg inquired about past initiatives to bring revenue to the Town. Finance Director Lalla explained where the Town obtains its revenue.
