



RESOLUTION NO. 2026-009

A RESOLUTION OF THE TOWN COMMISSION OF THE TOWN OF HIGHLAND BEACH, FLORIDA, SETTING THE PROPOSED NOT TO EXCEED MILLAGE RATE PURSUANT TO SECTION 200.065(2)(B), FLORIDA STATUTES, AND SETTING THE DATE, TIME AND PLACE AT WHICH A PUBLIC HEARING WILL BE HELD TO CONSIDER THE PROPOSED MILLAGE RATE AND TENTATIVE BUDGET

WHEREAS, Section 200.065, Florida Statutes, commonly known as the “Truth in Millage” or “TRIM” Act, provides that each taxing authority shall advise the Property Appraiser of its proposed millage rate, of its current rolled back rate, and of the date, time, and place at which a public hearing will be held to consider the proposed millage rate and tentative budget.

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN COMMISSION OF THE TOWN OF HIGHLAND BEACH, FLORIDA, THAT:

Section 1. The foregoing “WHEREAS” clause is ratified and confirmed as being true and correct and is incorporated in this Resolution.

Section 2. The proposed not to exceed tax millage rate of the Town of Highland Beach for Fiscal Year 2027 shall be:

Operating Millage:	3.4227
Debt Service Millage:	<u>0.1648</u>
Total Proposed not to exceed Millage Rate:	3.5875

Section 3. The Operating Millage rolled-back rate for Fiscal Year 2027 is 3.2780 mills. As defined in Section 200.065, Florida Statutes, the “rolled-back rate” is that certain millage rate which, exclusive of: new construction, additions to structures, deletions, increases in the value of improvements that have undergone a substantial rehabilitation which increased the assessed value of such improvements by at least 100 percent, property added due to geographic boundary changes, total taxable value of tangible personal property within the jurisdiction in excess of 115 percent of the previous year’s total taxable value, and any dedicated increment value, will provide the same ad valorem revenue as was levied during the prior year less the amount, if any, paid or applied as a consequence of an obligation measured by the dedicated increment value.

Section 4. The date, time, and place of the public hearing to consider the proposed millage rate and tentative budget shall be as follows:

Section 5. This Resolution shall be in full force and effect immediately upon passage and adoption.
