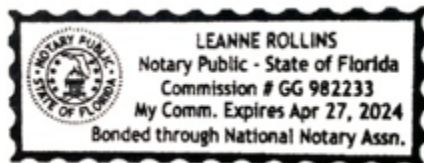

APPLICATION BY DARRIN DUNLEA, SEADAR BUILDERS, FOR AN AMENDMENT TO A PREVIOUSLY APPROVED SPECIAL EXCEPTION REQUEST (DO#21-0002) TO INSTALL A 232 SQUARE FOOT WOOD DOCK, TWO (2) MOORING PILES, A 12,000 POUND CAPACITY JET SKI PLATFORM LIFT, AND A 30,000 POUND CAPACITY NO PROFILE BOAT LIFT FOR THE PROPERTY LOCATED AT 4206 INTRACOASTAL DRIVE.

The Town of Highland Beach does not provide such a record.
