He highlighted several house bills of concern, including the sovereign immunity caps, which may impact insurance and HB 943. He congratulated Commissioner Chudnofsky and thanked Evalyn David for her guidance and support. Lastly, he reminded the residents about the upcoming Town Commission Spring Fling scheduled for Thursday.
