 - The board reviewed the Unified Development Ordinance for sidewalks when payment is in lieu of unbuildable sidewalk.
 - The board will advocate for sidewalk safety from Forest Ridge over US Highway 70A to the North Carolina Department of Transportation.

- The skate spot construction documents are available.
- All parks are getting pressure washed, and Gold Park restrooms will be painted.
