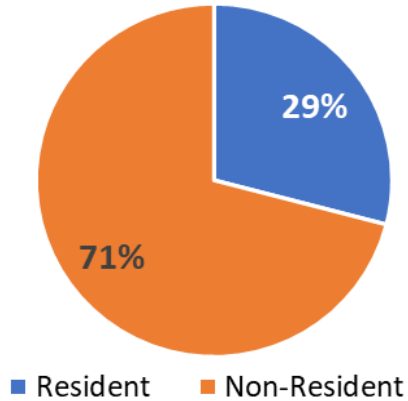

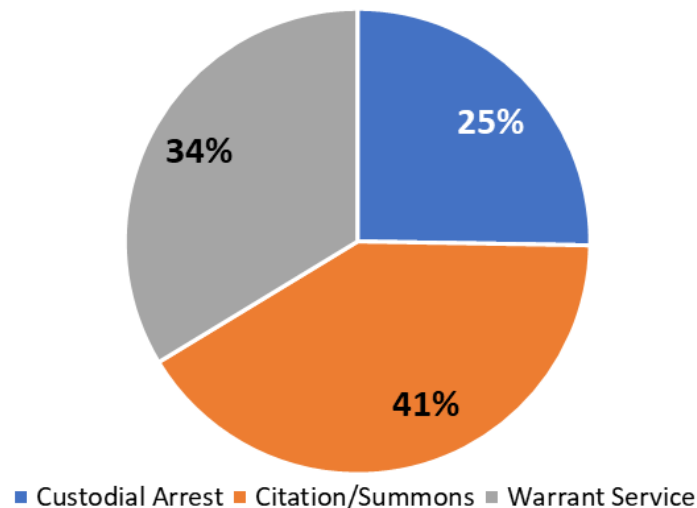
Definitions:

Custodial Arrests are typically on-view crimes for which an officer makes a physical arrest and takes the subject before a magistrate.

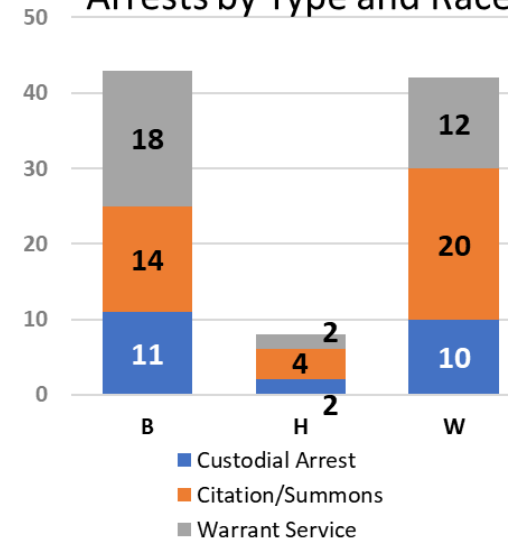
Warrant Service means an officer made a physical arrest for a previously existing warrant or order for arrest.

Citation/Summons means the offender was issued a citation or served a summons and was not physically taken into custody.

Summary of Complaints

- A citizen complained that an officer was rude and unprofessional (Sustained).
- A citizen filed a complaint that was deemed to be not related to Hillsborough Police Department's services (Unfounded).

Definitions:

Sustained – allegation found to be valid and the officer's actions were against policy or expectations.

Not Sustained – officer's actions were within policy and expectations, or there was insufficient evidence to prove or disprove the allegations.

Unfounded – Allegation was found to be baseless or untrue.

Details on Displays of Force

- An officer responded to a disturbance involving two subjects and tried to calm them down. One of them was loud and verbally abusive and refused officer commands. The officer displayed their taser to get compliance.
- Officers assisted a neighboring agency with a felony vehicle stop. They displayed their firearms until the scene was secure.
- An officer displayed their firearm when searching a residence for a subject with warrants.

PEWS Note: PEWS is a "Personnel Early Warning System," that is designed to initiate a review when individual officers are involved in multiple incidents over a defined period of time to ensure there is not a developing pattern of concerning behavior.

HPD has been transitioning its PEWS process to an electronic system to better identify and track activations of the PEWS system. As a result, prior quarterly reports did not capture and report the PEWS data. All PEWS activations have been reviewed.

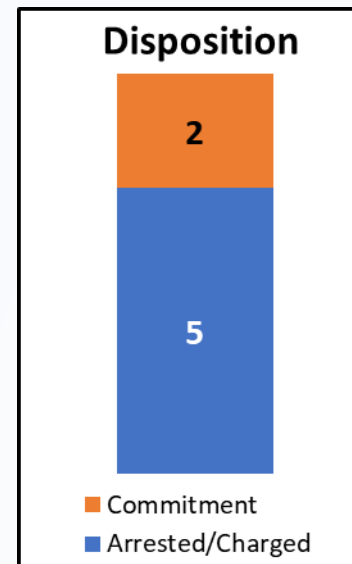
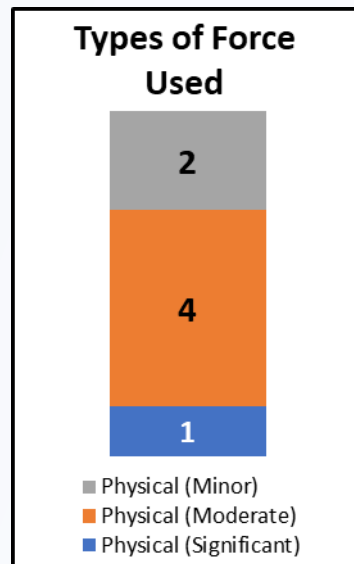
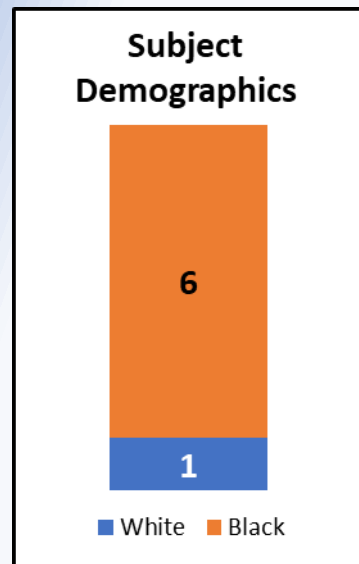
HPD's review of 10 force-related incidents this quarter found that force of some type was used in 7 of the incidents and involved 7 subjects and 13 officers.

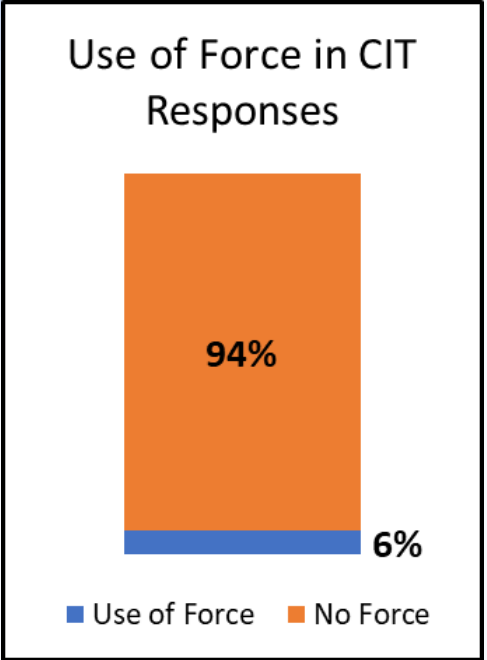
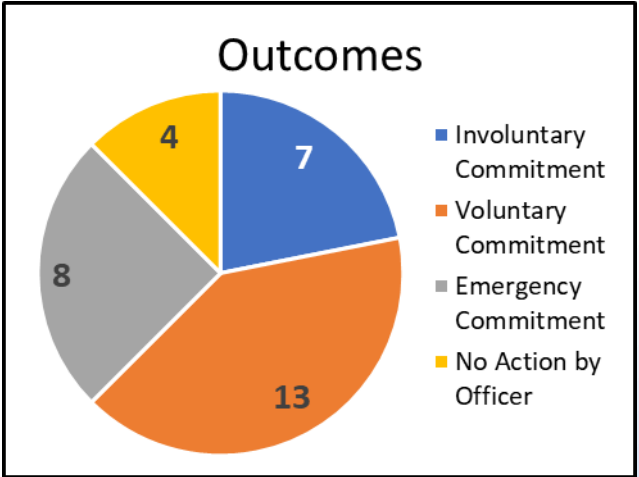
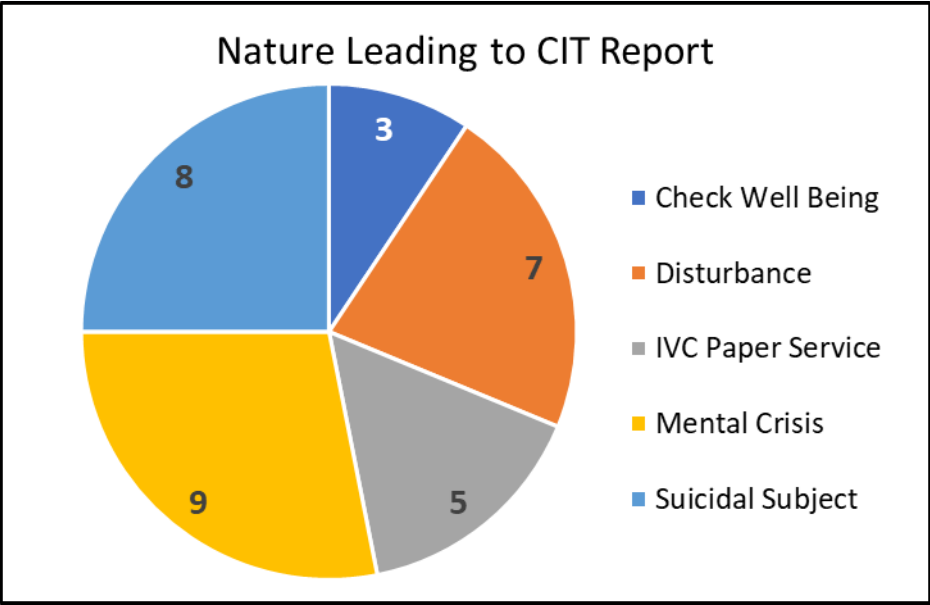
- During the arrest of a larceny suspect, the suspect resisted officers attempt to search them and refused to cooperate. Officer had to pull the subject's arm and subject pulled away repeatedly. Subject eventually complied with the officer's commands. (*Physical – minor*)
- Subject assaulted another person and was impaired at a business. Officers attempted to calm the subject down, but subject continued to escalate. Officers had to assist the subject to the ground where he was handcuffed and placed under arrest. (*Physical – moderate*)
- Officers used force to detain an agitated subject who had assaulted his girlfriend by grabbing his arms and placing them behind his back for handcuffs to be applied. (*Physical – moderate*)
- Suspect was running away from an officer who was attempting to place them under arrest. The officer took the subject to the ground and handcuffed them. (*Physical – significant*)
- Impaired subject charged toward officers and was placed under arrest. Officers had to grab subject's arms and restrain them during handcuffing. (*Physical – moderate*)
- 2 uses of force involved subjects in crisis and are detailed in the Mental Health Calls section.

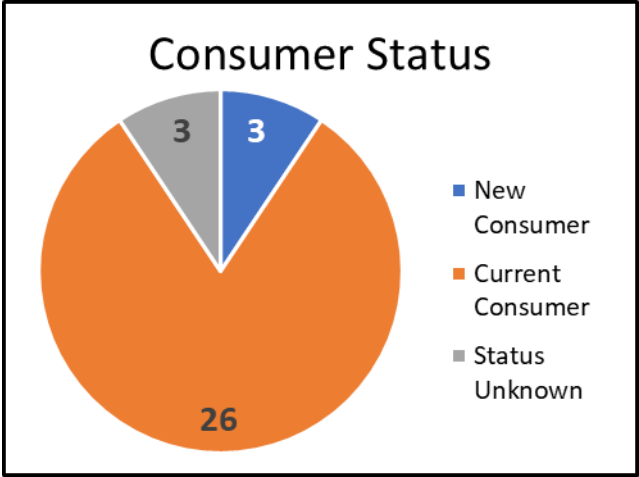

Details of Use of Force Situations:

- Officers were forced to restrain a consumer who refused to leave a business by handcuffing the consumer and placing him in a patrol vehicle. Officers were forced to restrain the consumer again at the Magistrate's Office. *(Physical – minor)*
- Officers were forced to restrain a consumer who refused to be transported for IVC papers. The consumers arm had to be physically forced behind their back for handcuffing. *(Physical – Minor)*



Multiple Reports: There were three consumers with multiple reports this period. One juvenile with two reports and two adults, one with three reports and one with four reports.

Search Details

- 1 search was protective frisk of a subject that told officer there may be a gun in the car.
- 3 searches were done after (incident to) an arrest.
- 6 searches were based on probable cause:
 - Officer saw an open container and then found evidence of drug activity and 2 guns in the car.
 - Subject was stopped for erratic driving and found to have an Involuntary Commitment Order. While being taken into custody for that order officers saw subject drop bag of drugs.
 - Officer stopped a vehicle that was reported to have been seen with an open container and observed the open container.
 - Officer smelled marijuana and the driver admitted to having marijuana in the car.
 - Driver officer stopped was smoking a marijuana joint and had an open container. A gun was also found in the car.
 - Officer stopped car for erratic driving and smelled marijuana and alcohol. Driver admitted to having marijuana and a gun in the car.

Of the 10 incidents with searches, 8 (80%) resulted in an arrest or criminal charge. Of those 8, only 5 arrests involved charges resulting from contraband found during the search. The other 3 arrests were not connected with the search.

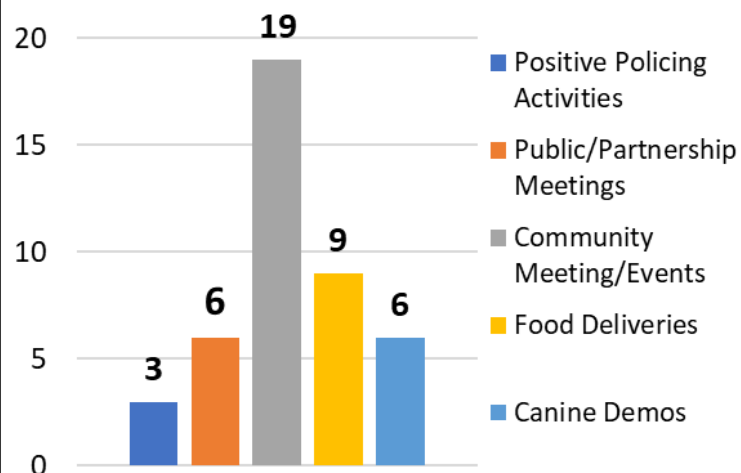

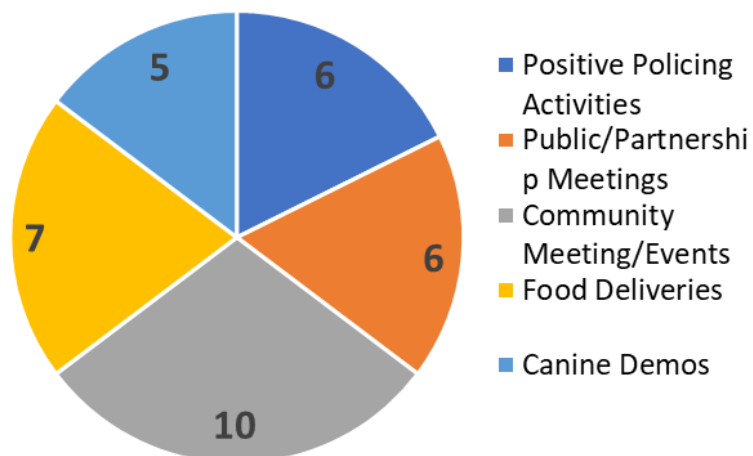
Definitions

- Positive Policing Activity – Services and actions by officers that go beyond the typical definition of policing. This can include acts of kindness and service, helping with problems, and providing meals or support to community members.
- Public/Partnership Meetings – Meetings with an agenda focused on community issues that intersect with policing such as Board of Commissioners or Project Safe Kids meetings.
- Community Meetings/Events – Community-based activities organized by the department or the community where officers attend, collaborate and/or coordinate, such as community watch meetings or events like Fairview Live.
- Food Deliveries – Assisting with food delivery to Hillsborough residents with mobility challenges such as Meals on Wheels and Passmore Center food box deliveries.
- Canine Demos – Educational demonstrations put on by HPD canine teams.

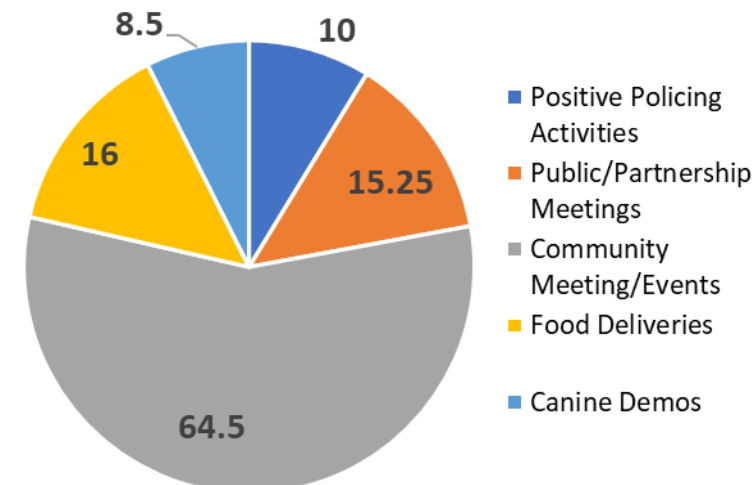

Positive Policing Activities

- A female came into the PD and was quite upset and frantic and needed a place she could print off her son's proof of residency to get his permit at the DMV. We had her email the document to a work email address and printed it off for her. There was a language barrier, but after 4 tries to get the email correct, we were able to help her out and she was very gracious.
- April Thompson with Orange County Strong NC handles multiple donations throughout the year for the community. Currently, HPD is helping to accept and deliver donations for a mother of 4 that left a domestic violence situation where her home was burnt down. We are also accepting and delivering donations for a project she will be doing to do crafts at a local senior living home with seniors.
- During his shift, an officer located multiple garages open and made contact with the owners about the dangers of leaving them unsecured.
- After taking a report of a vehicle break in, an officer drove to the store and bought duct tape and taped the victim's vehicle (Jeep) top cover up from the damages during the break-in. The citizen was very appreciative of our efforts.
