## From Inframark:

We converted to a new Meter Reading Dashboard. We made an error when scheduling the meter read by confusing the billing month. Mgr thought the statement date was 11/8 due 12/10 rather than 12/3 due 1/10/25. Because he went "backwards" so many days and we were already reading in advance, we can't correct the difference in one month.

## Inframark Solutions:

Option #1: to get back to normal (i.e. where we are reading the meters 8-10 days before the 10th of the month) will take all of 2025. We have to move 30 days to get back on track. We can't do that in one month or it would be a 90-day read cycle. So, we propose moving the dates ~5 days for each of the next 5 billing cycles. To get back to normal, and continuing to bill in the even months, with payments due in the off months, we need the read dates listed above.

Option #2: we bill in March (an odd-numbered month) instead of April and then bill thereafter in odd months.

Option #3: does the City have any interest in moving to monthly meter reading and billing? Pros: (1) the City receives its revenue earlier. (2) If a customer has a leak, they are made aware of that earlier. (3) Rate changes can be done monthly if needed.
