

Cassie,

Hope you had a good weekend and is not busy during spring break. After we talked about the City's needs I checked the roadways within Hilshire Village and put together a preliminary map of locations where traffic data might be needed (see snippet below). As I mentioned there are around 3-4 companies in the Houston area that do traffic data collection. They are NDS, Ally General Solutions and CJ Hensch. All of them charge around \$600 to \$1200 per location for a day (13 hr) turning movement counts and around \$150-250 for 24-hour counts. Based on the needs I show on the map the cost would be between \$3,500 to \$4,500, depending on the vendor we chose and the type of data collection we request.

Since you mentioned that the traffic engineering effort needs to be within a certain budget, we can do a quick evaluation of study roadways and develop engineering recommendations for these roadways. We can complete the study with a focus on addressing some of the concerns that Hilshire Village City Council and residents have. Please let me know what would be a good time to discuss this further. Thank you.
