Dear Mayor and City Council Members:

On August 7, 2025, eight (8) bids were received on the above-mentioned project. The following is a summary of our bid evaluation. Please see Section 1 of this report for a copy of the bid tabulation.

1. Bid Tabulation Sheet – Eight (8) construction firms participated in the bidding process. Each bid was checked for mathematical errors and/or bid irregularities. Errors were discovered on four of the bids. The appropriate corrections to the errors were made and included in the attached bid tabulation. The errors did not affect the order of the bids. A copy of the bid tabulation is attached with this report.

The bid totals for the project are as follows:

<u>Evaluation of the Apparent Low Bidder</u> – CAAN Construction Enterprises, LP provided a Qualification Information Package including references, completed, and working projects. Please see Section 2 of this report. HDR reviewed the completed projects and the recent projects they listed were for private developments which is not similar to this project in fully established residential neighborhoods. The last paving and drainage project CAAN



Construction Enterprises, LP performed was in 2015. Due to the dismantling of the City of Houston Construction Group, the references provided by CAAN Construction Enterprises, LP, except for one, were unable to be contacted. Upon meeting with CAAN Construction Enterprises, LP, on August 25<sup>th</sup>, 2025, it was discussed that the Contractor would be utilizing their Subcontractor, Match and Mix Construction, LLC, for a majority of the work. HDR requested that Match and Mix provide references. Four (4) references were contacted by telephone and asked to respond to a series of questions. The references indicated that, in more recent years, there have been issues regarding the completion and quality of work. Some of the references indicated that they were not satisfied with the work Match and Mix Construction, LLC provided and would not use them in the future. Please see Section 3 of this report for a copy of the reference questionnaires.

CAAN Construction Enterprises, LP and Match and Mix Construction, LLC presented their qualifications at the Hilshire Village Regular Council Meeting on September 16, 2025. The City Council unanimously voted to disqualify CAAN Construction Enterprises, LP and their subcontractor, Match and Mix Construction, LLC, as they did not feel that they had the necessary qualifications or experience.

After reviewing this information, CAAN Construction Enterprises, LP, as well as their subcontractor Match and Mix Construction, LLC, do not appear to have the experience or staff to perform the specified work in a satisfactory manner. For these reasons, CAAN Construction Enterprises, LP, is not the lowest responsive bidder.

<u>Evaluation of the Lowest Responsive Bidder</u> – Arnold and Co., LLC provided a Qualification Information Package including references, completed, and working projects. Please see Section 4 of this report. Four (4) references were contacted by telephone and asked to respond to a series of questions. The references indicated that they were satisfied with the work Arnold and Co., LLC had performed and would use them again in the future. Please see Section 5 of this report for a copy of the reference questionnaires.

After reviewing this information, Arnold and Co., LLC appears to be a responsible firm that is capable of performing the specified work in a satisfactory manner. For these reasons, HDR recommends that the City of Hilshire Village award the Hickory Shadows Paving, Drainage, & Water Line Improvements Project to Arnold and Co., LLC for a total bid amount of One Million One Hundred and Forty-One Thousand, Eight Hundred and Seventy-Nine Dollars and Fifteen Cents (\$1,141,879.15).

So, for the work in the field, I would give them a 7-8, but in compliance, I would say 6-5. It was very hard for us to have them be in compliance."
