# **City Treasurer's Report**

City Council Meeting Date: 11/19/2024

- **Request for Proposal:** The City is seeking a 3-year contract for audit services, with an option for a one-time 2-year extension. Following GFOA's recommendation to review financial services every five years, the City is issuing this RFP to ensure competitive pricing and quality service.
  - Our previous contract with Belt, Harris Pechacek expired, and the firm was recently acquired by Crowe LLP. Since Belt, Harris Pechacek has been our auditor since 2009, this is an opportunity for a cost comparison.
  - We will solicit proposals from auditors serving other Memorial Villages and similar-sized Texas cities. Public notices will be published for two consecutive weeks, and the final selection will be made at the December City Council Meeting.
