

ORDINANCE NO. 846-2025

AN ORDINANCE AMENDING NO PARKING ZONES TO PORTIONS OF RIDGELEY DRIVE PROVIDING A PENALTY IN AN AMOUNT NOT TO EXCEED \$200.00 FOR VIOLATION OF ANY PROVISION IN THIS ORDINANCE; REPEALING ALL ORDINANCES OR PARTS OF ORDINANCES INCONSISTENT OR IN CONFLICT HERewith, AND PROVIDING FOR SEVERABILITY.

WHEREAS, Texas Transportation Code Section 542.201 authorizes the City to enact and enforce rules regulating traffic that do not conflict with Texas's Rules of the Road; and

WHEREAS, Section 10.701 of the City's Code of Ordinances provides that "The city administrator is directed to maintain and to provide the city engineer, municipal court, and police department a schedule of designated streets, zones and traffic control devices, including, but not limited to, load limit zones, no parking zones, parking limit zones, speed limit zones, stop intersections and yield intersections"; and

WHEREAS, the City Council hereby finds and determines that it is in the best interest of the public that amendments be made to the Ridgeley Drive curve and southern Ridgeley Drive at its intersection with Wirt Road no parking areas as provided by Section 10.701 of the Code of Ordinances;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HILSHIRE VILLAGE, TEXAS:

Section 1. The City Council hereby designates the following curb zones on Ridgeley Drive as no parking areas, as provided by Section 10.701 of the Code of Ordinances of the City of Hilshire Village, Texas:

- A) On the west side of Ridgeley Drive, from the intersection of Mallie Court and Ridgeley Drive southward to the property line between 1101 Ridgeley Drive and 1105 Ridgeley Drive.
- B) On the east side of Ridgeley Drive, from a point approximately 20 feet north of the property line between 8201 Mallie Court and 1109 Ridgeley Drive southward to the intersection of Ridgeley Drive and Guinea Drive.

Section 2. The City Council hereby eliminates the south side of Ridgeley Drive from 100 feet of its intersection with Wirt Road as a no parking area, as provided by Section 10.701 of the Code of Ordinances of the City of Hilshire Village, Texas.

Section 3. The city secretary is directed to revise the Traffic Schedules maintained pursuant to Section 10.701 of the Code of Ordinances of the City of Hilshire Village, Texas, to reflect the amendments to the parking zones made by this Ordinance. The city secretary is further authorized to place signs in accordance with the provisions of this Ordinance.

Section 4. The city secretary is directed to provide to the city engineer, municipal court, and police department the revised Traffic Schedules.

Section 5. Any person, corporation or entity who shall violate any provision of this Ordinance shall be deemed guilty of a misdemeanor and, upon conviction, shall be fined in an amount not to exceed \$200.00. Each day in which any violation shall occur, or each occurrence of any violation, shall constitute a separate offense.

Section 6. All ordinances or parts of ordinances inconsistent or in conflict herewith are, to the extent of such inconsistency or conflict, hereby repealed.

Section 7. In the event any clause, phrase, provision, sentence, or part of this Ordinance or the application of the same to any person or circumstances shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not affect, impair, or invalidate this Ordinance as a whole or any part or provision hereof other than the part declared to be invalid or unconstitutional; and the City Council of the City of Hilshire Village, Texas, declares that it would have passed each and every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional, whether there be one or more parts.

Section 8. This ordinance shall be effective immediately upon adoption and publication of this ordinance or a caption that summarizes the purpose of this ordinance and the penalty for violating this ordinance in every issue of the official newspaper for two days, or one issue of the newspaper if the official newspaper is a weekly paper, in accordance with Section 52.011 of the Texas Local Government Code.
