Sec. 3.401. International Property Maintenance Code

- (a) The International Property Maintenance Code, 2024 Edition, as published by the International Code Council, Inc. (the "Property Maintenance Code"), and as amended herein, hereinafter sometimes referred to as the "code," is hereby adopted and made a part of this article. The Property Maintenance Code is adopted pursuant to Section 214.001 of the Texas Local Government Code to provide minimum standards for buildings and structures regardless of the date of construction.
- (b) This code shall not be construed to relieve or lessen the responsibility of any person owning, operating, or controlling any building or structure for any damages to persons or property caused by defects, nor shall the city council, the city, its agents or representatives assume any such liability by reason of these regulations or the inspections authorized by this code or any permits or certificates issued under this code.
- (c) This code shall not be construed to relieve or lessen the responsibility of any person owning, operating, or controlling any building or structure for any damages to persons or property caused by defects, nor shall the city council, the city, its agents or representatives assume any such liability by reason of these regulations or the inspections authorized by this code or any permits or certificates issued under this code.

<u>Section 9.</u> Any person who shall intentionally, knowingly, recklessly, or with criminal negligence violate any provision of this Ordinance, shall be deemed guilty of a misdemeanor and, upon conviction, shall be fined in an amount not to exceed \$2,000. Each day of violation shall constitute a separate offense.

<u>Section 10.</u> The Codes adopted herein and the City's Zoning Ordinance shall be cumulative. To the extent there may exist any conflict or inconsistency between the terms of the City's Zoning Ordinance, as amended, and the Codes adopted herein, the more restrictive of the two documents shall prevail and shall be interpreted and enforced according to its own terms.

<u>Section 11.</u> In the event any clause phrase, provision, sentence, or part of this Ordinance or the application of the same to any person or circumstances shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not affect, impair, or invalidate this Ordinance as a whole or any part or provision hereof other than the part declared to be invalid or unconstitutional; and the City Council of the City of Hilshire Village, Texas, declares that it

would have passed each and every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional, whether there be one or more parts.

Section 12. This ordinance shall take effect October 1, 2025.
