

RESOLUTION NO. 39-2025
CITY OF HINCKLEY
A RESOLUTION CERTIFYING ASSESSMENT OF UNPAID CHARGES

WHEREAS, pursuant to proper notice duly given as required by law, the City Council has met, heard, and passed upon all objections to the proposed certifications of unpaid charges for municipal fees and city services; and

WHEREAS, the amounts of bad debt have been minimized through diligent collection efforts by staff.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF HINCKLEY, MINNESOTA AS FOLLOWS:

Such proposed certification of unpaid charges, a copy of which is hereby attached as Exhibit 1 and made a part hereof, is hereby accepted and shall constitute a lien against the lands named herein.

Such certification shall be payable over a period of one year on or before the first Monday in January.

The owner of the affected property may, at any time prior to certification of unpaid charges to the County Auditor, pay the whole of the certified unpaid charges on such property, including penalties accrued to the date of payment, to the City of Hinckley Staff. The taxpayer may, at any time thereafter, pay the City of Hinckley the entire amount certified and remaining unpaid. Such payment must be made before **Thursday, November 20th, 2025.**

The clerk shall forthwith transmit a certified copy of this certification role to the County Auditor to be extended on the property tax lists of the county, and such certified unpaid charges shall be collected and paid over in the same manner as property taxes.
