As the City of Hinckley (Regulated Party) is unable to submit any biosolids sampling data from the last three years for MPCA review, the MPCA be issuing the Regulated Party an additional enforcement action to address the missing biosolids samples as are referenced in corrective action 1c. The additional enforcement action will likely be a Notice of Violation, but I will let you know if that changes after I speak to MPCA supervisor assigned to this facility.
