

Charter Review Committee Minutes

October 15, 2025

Chair Dave Drotzmann called the meeting to order at 5:30pm. Committee members in attendance included: Val Hoxie, Rod Hardin, Kyndra Stone, Paul Wolverton, Karyn Jones, and Monique Brandley. Also present was Mayor Doug Primmer as Council representative, and staff to include: City Manager Byron Smith, City Attorney Rich Tovey, and City Recorder Lilly Alarcon-Strong.

Introductions

Committee members and staff in attendance introduced themselves and members shared why they wanted to be involved in the Charter Review Process.

Mayor Primmer thanked the Committee for their involvement in this very important process.

Review Expectations of the Charter Review Committee

Dave, Doug, and Lilly spoke regarding: attending meetings when scheduled, public retention and disclosure requirements, open and serial meeting laws for members to be aware of.

Review Charter

Byron presented and reviewed the 2015 Adopted City Charter (PowerPoint Presentation attached), and emphasized the specific recommendations the Council asks that the Committee evaluate, to include:

- Geographic representation on the Council,
- · Ward boundary adjustments,
- The process for adopting ordinances,
- The hiring and supervision of the city attorney,
- The selection method for the municipal court judge, and
- The necessity of a city manager residency requirement

Byron stated tonight's meeting was intended to give a brief overview of the entire Charter and answer questions; then, take a deep dive into each section of the Charter at each future meeting until the Committee has completed their review and is ready to give their recommendations to Council.

Committee members asked for the following:

- At the next meeting
 - The Charter to be printed for each Committee member
 - A population/ward density map be prepared and presented
- At a future meeting
 - City Planner Clint Spencer present information on ward boundaries
 - Municipal Court Judge Cameron Bendixsen attend a meeting

Byron stated he will also be asking the League of Oregon Cities Executive Director Patty Mulvihill to attend a future meeting to present information as well.

No other items were presented or discussed.


Public Comment

Adjournment


There was no other business and Chair Drotzmann adjourned the meeting at 6:18pm.


