This is Amendment No. 02 to the Agreement between the **State of Oregon**, acting by and through its Department of Transportation, hereinafter referred to as "State," or "ODOT" and City of Hermiston, acting by and through its elected officials, hereinafter referred to as "Agency," entered into on July 25, 2018, and Amendment Number 32616-01 entered into on January 31, 2023.

Agency certifies that the representations, warranties and certifications in the original Agreement are true and correct as of the effective date of this Amendment and with the same effect as though made at the time of this Amendment.
