



# Solid Waste & Curbside Recycling Advisory Committee Meeting Minutes

May 11, 2026

---

Assistant City Manager Mark Morgan called the meeting to order at 5:30pm. Councilors McCarthy (arrived at 5:32pm) and Hayward were in attendance, as well as City Manager Byron Smith, Police Chief Jason Edmiston, and City Recorder Lilly Alarcon-Strong.

## **Review Solid Waste Rates**

Assistant City Manager Mark Morgan stated the City received a request from Waste Connections dba Sanitary Disposal for a rate adjustment of 5% effective July 1st, 2026 due to inflation, necessary upgrades for improved safety, reliability and regulatory compliance, as well as labor costs. The last rate adjustment to solid waste fees was in March of 2024 and since that time the national consumer price index of inflation has risen 6.62%.

The City has asked Waste Connections dba Sanitary Disposal if they would consider a 3.5% rate increase and City reduction of 1% in billing fee and .5% in franchise fee instead with an effective date of July 1st, 2026. This 1.5% will reduce the general fund revenues by about \$65,000.00, however, because of the new state required recycling mandate slated to begin on July 1st, 2026, this service will also generate the same amount, \$65,000.00, in billing and franchise fees and therefore cancel each other out.

Waste Connections District Manager Kevin Miracle stated they are willing to accept the recommendations given by the City and stated they are not asking for a large increase, just the standard growth of CPI and general costs increases to maintain equipment and personnel (Request for rate adjustment attached).

## **Committee Discussion and Recommendation to City Council**

Assistant City Manager Mark Morgan stated this information would be presented to the City Council at their next meeting on Tuesday, May 26th.

Councilor McCarthy asked Mr. Miracle what the outcome would be if the Council does not approve this adjustment.

Mr. Miracle stated he would return to the City for further negotiations and a possible compromise.
