We will be serving 3rd grade through 8th grade youth. Within this program, we strive to provide youth with a more competitive, organized tackle football program that will propel them forward. This program will be tightly associated with the Hermiston High School Football with head coach David Faaeteete, and assistant Mike Mosher who will work in coordination with our board, to provide the youth football coaches with guidance, allowing a more uniform way to practice and play. | <b>PROJECT INFORMATION</b>      | <p>Funding Request: \$ <u>4,600</u></p> <hr/> <p>How many people will benefit from this project? <u>100 athletes</u></p> <hr/> <p><b>Project Description:</b> (attach additional pages if necessary)</p> <p>The Hermiston/Pendleton Special Olympics Local Program #510 engages athletes with intellectual/developmental disabilities in year-round training and competition in Umatilla and Morrow Counties and is facilitated entirely by volunteers who manage the program and coach the athletes. We are requesting funding to cover the cost of bowling for our athletes who train and compete in Hermiston at Desert Lanes and in Pendleton at Wildhorse during the fall months. Approximately eighty to ninety athletes train and compete in bowling each fall. The cost of bowling at the two facilities including the regional competition is \$3,500. Bowling is the most popular sport in our Special Olympics program.</p> <p>Another sport that our local program offers in the spring/summer every year is bocce`. This sport is growing in popularity with our local athletes. We have adequate equipment to serve our athletes who do not have mobility challenges. Unfortunately, our wheelchair athletes are unable to participate in bocce` since we are not able to afford the specialized ramp required to train and compete in half-court bocce` matches (please see attached documentation). The cost of the ramp is \$1,100. This ramp would allow this group of athletes to engage in a sport during the spring/summer season. Without this ramp, these athletes can only watch from the sidelines.</p> <p>Our management/coaching team works very hard to recruit new athletes every year. This team consists of about six to eight dedicated individuals who also serve as coaches for multiple sports. Receiving a grant will allow these individuals to focus their efforts on coaching, athlete recruitment and retention instead of the time consuming task of additional fundraising. We will continue to provide the various fundraising events throughout the year (e.g. golf tournament, Bowl-a-thon, etc.) but this grant would go a long way to ease the financial burden of providing sporting opportunities to even more athletes in Umatilla and Morrow Counties.</p> |
