
ACTIVITES





- We currently have two county foster homes


ACTIVITY UPDATES










Basic Needs services Huerfano and Basic Needs Services Las Animas



Organizational Report

STAFF

- One staff member is out on extended leave.
- Our DHS Attorney position is being temporarily filled by Juile Ripperger
- Roger Greene will no longer perform Family Engagement Meetings for Huerfano County but will continue to support other family meetings through truancy and other programs.

OPERATIONAL MANAGEMENT

- Voicemail continues to be spotty.
 - We received a quote from Gobbins for a new phone system but are waiting to hear from other vendors through Sourcewell to provide quotes so we have several options to present to the board.
- We continue to refine the call center operations.
- We are working with partner organizations and with Las Animas county to envision what services should and could look like in our area.
- The computer refresh for this year's cycle is completed.

LEGISLATIVE UPDATES

- The state has advised us to expect rule changes related to all areas of DHS coming down as a result of the most recent legislative sessions.
- The state has a new funding model for eligibility and for child welfare, and we should expect to see our new allocations in June.

ACTIVITIES

- The eligibility unit got 100% customer satisfaction on its most recent survey results.
- Director and Eligibility supervisor attended DEWs Forum
- Director has been attending SE Director's meetings
- Participated in Safe Baby team meeting and advisory committee.
- Director and Eligibility supervisor met with Workforce development to align our programs.
- Director met with Crossroads to negotiate contract and discuss services.
- We completed an onsite meeting with the State County Liaison and received support.
- The state liaison from child welfare had an onsite visit with the team.
- Deah Weller continues to participate in hunger relief initiatives.
- We prepared most of the required documents for the audit, and met with the auditor and accounting consultants.
- Karina has successfully fixed our state payroll upload issue and has now uploaded all payroll.
- Karina has attended training through the state and a private vendor to learn DHS accounting.
- DHS staff will attend the CCI conference at the end of May.
- We conducted a whole staff training on April 19 covering setting expectations and boundaries with clients.
- We are nearly caught up in the Assistance Payments Unit and our timeliness continues to improve.
- We continue to work on building a stronger relationship between The FRC and CW offices.
