AN ORDINANCE OF THE CITY OF HUTCHINS, TEXAS, AMENDING THE CODE OF ORDINANCES BY AMENDING APPENDIX A TITLED "FEE SCHEDULE" BY ADDING A NEW SECTION A1.010 TITLED "EVENT CENTER FEES" TO SET FORTH FEES FOR THE EVENT CENTER; AND PROVIDING FOR AN EFFECTIVE DATE.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF HUTCHINS, TEXAS:

<u>Section 1</u>. That the Code of Ordinances of the City of Hutchins, Texas, is hereby amended by amending Appendix A titled "Fee Schedule" by adding a new Section A1.010 titled "Event Center Fees", to read as follows:

<u>Section 2</u>. That all provisions of the Ordinances of the City of Hutchins, Texas, in conflict with the provisions of this Ordinance be and the same are hereby, repealed, and all other provisions of the Ordinances of the City of Hutchins not in conflict with the provisions of this Ordinance shall remain in full force and effect.

<u>Section 3</u>. That should any sentence, paragraph, subdivision, clause, phrase or Section of this Ordinance be adjudged or held to be unconstitutional, illegal, or invalid, the same shall not affect the validity of this Ordinance as a whole or any part or provision thereof other than the part thereof decided to be unconstitutional, illegal, or invalid.

<u>Section 4.</u> That an offense committed before the effective date of this ordinance is governed by prior law and the provisions of the Ordinances of the City of Hutchins, as amended, in effect when the offense was committed and the former law is continued in effect for this purpose.

<u>Section 5</u>. That this ordinance shall take effect immediately from and after its passage and the publication of the caption as the law and charter in such cases provide.
