## CITY OF HUTCHINS RESOLUTION NO. R2025-11-1293

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HUTCHINS, TEXAS AUTHORIZING THE CITY ADMINISTRATOR TO PURCHASE ONE NEW 2026 FORD CHASSIS FOR REMOUNT ON AMBULANCE FROM FRAZER, LTD AT THE QUOTED BID PRICE OF \$309,700.00 UTILIZING BUY BOARD OF TEXAS; APPROPRIATING FUNDS FROM FISCAL YEAR 2025/2026 BUDGET; AND ESTABLISHING AN EFFECTIVE DATE.

- **WHEREAS,** on September 15, 2025, the City Council of the City of Hutchins approved Ordinance Number 2025-09-1212 officially adopting the Fiscal Year 2024/2025 Budget; and
- **WHEREAS,** in the adopted Fiscal Year 2024/2025 Budget, funds were budgeted for the purchase of one (1) Ford Chassis for New Ambulance Remount, and
- **WHEREAS,** Texas Local Government Code Section 791.001 authorizes members of the Local Government Purchasing Cooperative to utilize Buy Board in order to comply with State bidding requirements; and
- **WHEREAS,** the City of Hutchins is a member of the Local Government Purchasing Cooperative; and
- **WHEREAS,** the City has obtained a quote from Frazer Bilt of Houston for the 2025 Ford Chassis for Ambulance Remount utilizing Buy Board for the purchase this vehicle; and
- **WHEREAS,** the bid quotes from the following vendor establishes the total price to purchase this vehicle as follows: Frazer Bilt for the purchase of the Ford Chassis for Ambulance Remount for \$274,250.00; and Frazer Bilt for the purchase of the Power Load Stretcher System at \$35,450.00, Budgeted in the Fire Department Operation Budget; and
- **WHEREAS,** the City Council finds that it is in the best interest of the City and its citizens to authorize the City Administrator to purchase this vehicle for the above bids utilizing Buy Board of Texas contract pricing as detailed in the attached quotes.

## NOW THEREFORE BE IT ORDAINED THAT THE CITY COUNCIL OF THE CITY OF HUTCHINS, DALLAS COUNTY, TEXAS:

- **SECTION 1.** That the City Council of the City of Hutchins, Texas hereby authorizes the City Administrator to purchase the Ford Chassis Ambulance Remount and Required Stretcher System for the Fire Department for the quoted price of \$309,700.00, and
- **SECTION 2.** That the City Council of the City of Hutchins, Texas hereby authorizes the appropriation of said funds from the FY 2025/2026 Budget (General Fund).
