B. Tree Board Involvement in Upcoming Sustainability Plan – Caitlyn Gendusa

- Ms. Gendusa discussed the City's proposed sustainability plan process and requested one member of the Tree Board attend each public information session on July 17th to host a table pertaining to land management. She will finalize date and provide a flyer to Tree Board members to circulate to the community.
- C. Bee City Update and Proposed Changes
- Ms. Gendusa will be taking over the lead role for the City of Hendersonville's Bee City Program. She will lead the effort to establish a volunteer coordinator for the city to cultivate a volunteer work force to establish and maintain more pollinator habitat within the city. The roles of the ESB and Tree Board are to be defined. The Tree Board expressed that they are more interested in project related work and would prefer for the ESB to handle education and outreach for Bee City. A meeting is to be scheduled for a committee to work through this process and define the roles.
