Hurricane Helene greatly impacted our ability to fulfill our mission of providing quality services to our community. Our Water and Sewer Department saw water extraction and treatment severely damaged with several millions of dollars in estimated repairs needed. Our City was impacted in a multitude of ways and the full extent of repairs needed is still being sorted through. Water & Sewer customers were without safe drinking water for over two weeks. Our trash and recycling services were canceled for two weeks and as of the date of this submission we have still been unable to recycle due to ongoing contamination due to storm debris. Currently we are unable to fully provide quality services without outside help of other municipalities providing their Public Works and Fire Department staff. Through adversity, the City has done great work in opening an Emergency Operations Call Center to maintain our mission of open communication and timely responses however, our ability to provide quality services will continue to take time to be back to normal. While there are many essential services impacted, Our Water & Sewer operations remains one of the most vital to repair. As such, the City of Hendersonville requests \$25,000 to go towards offsetting the unforeseen cost of replacing 10 Water & Sewer vehicles that were flooded and subsequently totaled as a result of Hurricane Helene.

While we have insurance on all vehicles, that still leaves \$40,000 in deductibles that will not be paid for by any other funding source except the City's own funds. This means funding will have to be pulled from other essential services which impacts our ability to provide quality services if we don't have adequate funds. Currently, the City is borrowing vehicles from other municipalities as we look into replacements. Funding from the Community Foundation of Western North Carolina would greatly help in offsetting this cost so more funds can go back to repairing our other essential services for our community.

These funds will be used immediately to secure replacement Water and Sewer vehicles to ensure our community has access to reliable drinking water and sewer services.

Yes; The City of Hendersonville is eligible for FEMA funding which we have taken full advantage of where expenses are eligible. However, FEMA does not cover all unforeseen costs of the hurricane and is not covering vehicle replacement deductibles.

Hurricane Helene caused catastrophic flooding, damage to property, and most importantly loss of life. Unfortunately, Hendersonville was no exception. As of the date of this submission, the City is still under a State of Emergency and issued a Level 4 flood response plan for severe flooding when Hurricane Helene hit. Many residences and businesses were completely destroyed. There were 35 street closings, loss of power, water, and internet for over two weeks for residents and businesses. The N.C. Department of Health and Human Services reported 7 deaths in Henderson County. Impacts have also significantly impacted our economy with local businesses unable to operate for over two weeks or more and residents facing inability to work in cases where businesses were destroyed and services such as daycare and school suspended.
