On Wednesday, April 23, 2025, at 2:00 pm (EST), the City of Hendersonville received bids for the Hendersonville WWTF HVAC Systems Replacement project. As the minimum requirement of three (3) bids was not met, no bids were opened, and the project was re-advertised in accordance with procurement procedures.

On Thursday, May 15, 2025, at 2:00 pm (EST), the City received two (2) bids for the re-advertised project. These bids were publicly opened and read aloud. To the best of our knowledge, all advertisement and bidding procedures complied with applicable statutory requirements.

Please refer to the attached certified bid tabulation for the bids received. The bids have been reviewed by the Engineer, and Cooper Construction Company, Inc., of Flat Rock, NC (NC License #3522) has been determined the apparent low bidder, with a base bid amount of \$624,400.00.


