

APPROPRIATION OF COUNTY FUNDS FOR MEMBER LIBRARIES

February 2023



APPROPRIATIONS

- Lake County provides annual payments to the ten member libraries for their
 participation in the Lake County Library System via interlocal agreements (does not
 include the six County branches)
- Philosophically, this addresses potential double-taxation for municipal residents and partially reimburses the municipality for sharing city-funded resources with the rest of the county
- The payments consist of a Base Payment and a Circulation Allocation
- The current total for the annual appropriations is \$1,107,294 and is set by the Board of County Commissioners
 - The Base Payment is \$20,000 per member library (\$200,000 total for all ten member libraries)
 - Circulation Allocation is the remaining funds based on the number of physical items circulated from the member library



FY 22/23 APPROPRIATIONS

Base Amount: to assist with funding of programs and services at its participating library.

Circulation: each physical item that is either checked out from a member library or sent to another library and is checked out. (Includes renewals for owning library.) Stats are from two fiscal years prior.

Percent of Circulation: percentage circulated per member library based on the ten member libraries combined circulation.

Circulation Allocation: the remaining funds based on the percentage of circulation of physical items circulated from the member library.

WHAT IS AN APPROPRIATIONS (REDIT?

The Howey library receives one Appropriations Credit when:

- Any physical item is checked out at the Howey library
- Any item that is sent to another library and is checked out
 - Howey sends an item to Leesburg and it is checked out; Howey and Leesburg each get an
 Appropriations Credit
 - Minneola sends a book to Howey and it is checked out; Howey and Minneola each get an Appropriations Credit
- The owning library receives one appropriations credit for a renewal
 - Howey sends a book to Lady Lake that is checked out and then renewed three weeks later. Howey gets
 one credit for the transfer; Lady Lake gets one credit for checking the item out; Howey gets an
 additional credit for the renewal



APPROPRIATION CAVEATS

- To receive an Appropriations Credit, the item must be transferrable via courier and not for library-use only
 - No Appropriations Credit*:
 - Laptops/Chromebooks
 - Calculators
 - Kindles
 - Gaming Controllers

- Sports Equipment
- Cables
- Flash drives
- Hotspots

*List is not exhaustive

- If an item is sent to another library and is not checked out, then neither library gets an Appropriations Credit
- County branches do not get Appropriations Credits



APPROPRIATION CREDIT VALUE

- The Appropriations Credit per item can vary from fiscal year to fiscal year
- The more items checked out overall, the lower the value of the Appropriations Credit

FY 21/22	1,078,043 (FY 19/20)	84 cents *Eustis Library joined

FY 19/20	1,036,261 (FY 17/18)	76 cents



FUTURE OF APPROPRIATIONS

- Lake County is requesting a consultant to create a metric for Appropriations Credit that is not based solely on circulation or any other corruptible or manipulatable figure
- Examples include population, funding spent on library materials for circulation, funding spent on personnel, and other statistics
