M.J.J.A. "Home occupation" means an occupation performed wholly within a residence or the yard and accessory buildings being a part of such residence. Home

occupations shall not change the character of the residence or the residential neighborhood. A business license is required for some home occupations. They shall be issued for a one-year period and are renewable. The City Council may

review a license in reaction to neighbor's complaints and may revoke it if

evidence warrants this action.

	Level one applicants are in occupation categories that the City Council has determined have virtually no negative impact on residential neighborhoods and do not require a license. Occasional businesses operated by a minor are not required to obtain a business license.

They also may be required to meet with the City Council and explain how their home occupation is in conformance with the home occupation standards.
