ORDINANCE 24-13

WHEREAS, on January 6, 1994, the Hyrum City Council passed and posted an ordinance adopting the "Hyrum City Municipal Code", a recodification of municipal ordinances encompassing the "Revised Ordinances of Hyrum City" and ordinances adopted through July 15, 1993; and

WHEREAS, Title 10 of the Hyrum City Municipal Code adopts the Uniform Traffic Code and other regulations governing the operation of motor vehicles on city streets; and

WHEREAS, certain streets in residential neighborhoods have been used as thoroughfares for gravel trucks, semi-tractors, and other large vehicles, creating concern for the safety and welfare of other traffic and of children and pedestrians in these areas; and

WHEREAS, Section 41-6-17, Utah Code Annotated 1953, as amended, provides local authorities the right to regulate the use of city streets by certain classes or kinds of traffic to enhance or preserve safety in these areas; and

WHEREAS, to promote and protect the safety of motorists and pedestrians alike, the City Council has determined to post weight limit restrictions on certain residential streets within Hyrum City in accordance with Section 41-6-17, UCA, and each such street will be posted at each entrance as required by law.

NOW, THEREFORE, the Hyrum City Council hereby adopts, passes, and publishes the following:

AN ORDINANCE AMENDING CHAPTER 10.18, VEHICLE WEIGHT AND OTHER TRAFFIC RESTRICTIONS, OF TITLE 10 OF THE HYRUM CITY MUNICIPAL CODE.

BE IT ORDAINED by the City Council of Hyrum City, Cache County, State of Utah, as follows:

1. Chapter 10.18 is hereby added to Title 10 of the Hyrum City Municipal Code as follows:

Chapter 10.18

VEHICLE WEIGHT AND OTHER TRAFFIC RESTRICTIONS

Sections: 10.18.010 Weight restrictions. Ordinance 24-13 Page 2

10.18.010 Weight restrictions.

The governing body may impose vehicle weight limitations on certain streets within the municipality to limit or restrict a certain class or kind of traffic when such traffic, in the opinion of the governing body, poses a threat to other classes or kinds of traffic, pedestrians, or neighborhood residents. All such restrictions shall be clearly posted at the entrance to the street or part thereof affected by these regulations.

A. Commercial Vehicle traffic has been restricted on the following streets:

101	IOWING SCIECCS.
1.	500 West between 200 North and 300 North;
2.	400 West between 300 North and 400 North;
3.	300 West between 300 North and 400 North;
4.	400 North between 200 West and 500 West;
5.	1025 West between 300 North and 400 North;
6.	1300 South between 300 North and 300 South;
7.	Park Drive between 600 East and 800 East;
8.	Anderson Avenue between 600 East and 800 East; and
9.	600 East between Main Street and 100 North.

2. EFFECTIVE DATE. This ordinance shall become effective upon posting three (3) copies in three (3) public places within Hyrum City.

3. ADOPTION. This ordinance is hereby adopted and passed by the Hyrum City Council this 21^{st} day of November, 2024.
