I walked into the store and went to my right and then to the front of the store, that is where they have all of the glass smoking devices either on the wall or in a glass case out in the open where anyone who walks in can see, I continued down to the other side of the store and could see more glass and metal smoking devices in another glass case. The Spot Smoke and Vapor is in violation. My next stop was King Tobacco, I did not see anything on their door about being 21 to enter and as soon as you walk in there is a glass case and that is where they have all of their glass and metal smoking devices, Kind Tobacco is in violation.
