Staff participated in trainings while still doing daily tasks and did not have time to prepare the reports.

## PETITIONS FROM THE PUBLIC

Daniel Walter, Buchanan County EMS Advisory Council, presented information on the Buchanan County Emergency Medical Services (EMS) Essential Service Levy proposal.

Nathan Hansen, 800 Pine Dr SW, requested to address the Council on a potential amendment to City Code of Ordinance Section 152.02 – Interior Lot Restrictions. Council Member O'Loughlin with a motion to table the request until it can be discussed at a Council Work Session, second by Council Member Prusator. The roll being called the following Council Members voted: Ayes: O'Loughlin, Prusator, and Hanna. Nays: Jensen, Mayner, Moore, and Weber. The motion failed. Mr. Hansen would like to install a fence to allow his dogs out in the yard without having to be on a leash. He agrees there should be a written agreement between neighbors about the fence being on a property line but would like the distance requirement to be potentially amended. The current code states no fence, wall, or hedge shall be within three feet of the property line in any side or rear yard unless there is a written agreement. Council Member Moore with a motion to table the amendment to the September 2, 2025, Council Work Session, second by Council Member Hanna. The roll being called the following Council Members voted: Ayes: O'Loughlin, Prusator, Mayner, Moore, Hanna, and Weber Nays: Jensen.

## RESOLUTIONS

Council Member O'Loughlin with a motion to approve and authorize the Mayor to sign the resolution that approves the development agreement with Indee Storage, LLC, authorizing annual appropriation tax increment payments, and pledging certain tax increment revenues to the payment of the agreement, second by Council Member Moore. The roll being called the following Council Members voted: Ayes: Hanna, Moore, Mayner, Prusator, O'Loughlin, Jensen, and Weber.

Council Member Jensen with a motion to approve and authorize the Mayor to sign the resolution which agrees to provide and make available up to \$59,254.22 in local monies to meet the minimum local match requirement for the mitigation grant application, second by Council Member Mayner. City Manager Schmitz stated this grant application is in partnership with the City of Oelwein. The roll being called the following Council Members voted: Ayes: Moore, Mayner, Prusator, O'Loughlin, Jensen, Weber, and Hanna.

## Resolution adopted and upon approval by Mayor assigned No. 2025-64 in the Official Book of Resolutions.

Council Member Weber with a motion to approve and authorize the Mayor to sign the resolution that approves Pay Application #3 in the amount of \$176,859.51 to Eastern Iowa Excavating & Concrete LLC for the 8<sup>th</sup> Ave NW – IPF Area Stormwater Improvements Project, second by Council Member O'Loughlin. The roll being called the following Council Members voted: Ayes: Mayner, Prusator, O'Loughlin, Jensen, Weber, Hanna, and Moore.

The following comments were heard from Council and Staff: PD Monthly Reports – Council Member Hanna asked if the test drone flight is something the Police Department does? Chief Lau said they do not have a drone. Test drone flight is a type of call for service in the department's reporting software. Council Member Hanna also thanked the department for providing escorts for funeral services. That was very helpful last Friday when work was being done near the bridge. Moore – Encouraged residents to come to Meet Me on Main this Friday and participate in the dunk tank activity. Money raised from the dunk tank will be used for the July 4, 2026, celebration. Mayner – Sad to see that this is the last year of BrewBQ. O'Loughlin – Also encouraged residents to attend Meet Me on Main. City Manager – Staff posted a job opening for a part-time office assistant for the Independence Municipal Airport.
