Office of Emergency Management Update

OEM staff have been working with FEMA and Texas Division of Emergency Management regarding reimbursement of funds expended during Hurricane Beryl. OEM staff have completed the FEMA portion of the project and are currently working with TDEM to complete the remainder of the project. Most funds have been directly received from FEMA and the remainder will be disbursed through TDEM soon.

We are proud to announce that Sergeant King has successfully completed FEMA's National Emergency Management Basic Academy (NEMBA), a rigorous and comprehensive 157-hour program designed to build foundational knowledge in emergency management. The Academy includes 37 hours of independent study and 120 hours of intensive classroom instruction covering key topics such as emergency management principles, threat and hazard analysis, emergency operations planning, public information, and training and exercise evaluation.

Sergeant King's achievement was formally recognized by FEMA staff during a graduation ceremony held at the conclusion of the program. He will soon receive an official Certificate of Completion from FEMA, marking a significant milestone in his professional development and his commitment to excellence in public safety and emergency management.
