In accordance with Executive Council policy, we have examined the supplemental allocation request for 29C.20 funds for the above-mentioned damage. The Department of Public Safety has requested a supplemental allocation of \$30,000.00. It is our conclusion that the above-mentioned damage and additional costs expected to be incurred by the Department of Public Safety are covered by Chapter 29C.20 of the Code of Iowa. Therefore, we recommend an Executive Council approval of the supplemental allocation request of \$30,000.00, subject to an audit of actual invoices. This increases the total allocation to \$39,500.00.

AON 29C.20 revised allocation request ref. radome damage and antenna damage on the KTIN Bradgate ISICS communication tower. AOS #4168

State of Iowa Executive Council:

On 9-16-25, DPS personnel discovered a broken radome on the KTIN Bradgate ISCS tower. It is believed strong winds from severe storms in the area caused the damage. While radome repairs were in progress the repair team found water intrusion in the transmit antenna. This antenna will have to be replaced. The antenna damage was also caused by severe storms in the area.

Motorola Warranty Representative Dave Gordon was able to provide the DPS Interoperability Communications Bureau an estimate of \$9,500 for repairs to the radome and \$30,000 for repairs to the antenna. Repairs will commence once a tower crew becomes available.

The DPS Interoperability Communications Bureau is respectfully submitting a revised 29C.20 allocation request for a total of \$39,500 regarding this act of nature damage.
