Notice is hereby given that there is now on file for public inspection in the office of the Council of the City of Cedar Falls, State of Iowa, a proposed Resolution of Necessity, an estimate of costs and plat and schedule showing the amounts proposed to be assessed against each lot and the valuation thereof within District as approved by the Council of the City of Cedar Falls, State of Iowa, for a street, storm sewer, sidewalk and other public improvements, designated as the West 23rd Street Reconstruction from Hudson Road through Campus Street, of the types and in the location as follows:

The roadway improvements include reconstruction of W 23rd Street from Hudson Road through Campus Street and the addition of an 8' wide median between Hudson Road and the UNI Student Health Parking Lot. The new pavement will be 8" thick Portland cement concrete and 8" colored Portland Cement concrete at all crosswalks with a 12" granular subbase. The product will also include 6" diameter subdrains, storm sewer intakes, storm sewer manholes and painted pavement markings. Additional corridor improvements include, reconstructing sidewalks, new landscaping features, new street and pedestrian lights, new signage and monument features, and a retaining wall on the north side of W 23rd Street between Indiana Street and Campbell Hall that allows for an ADA accessible walkway from the grade at W 23rd Street down to the grade of the Campbell Hall parking lot. The two Student Health parking Lot accesses will be reduced to a singular entrance to further increase pedestrian safety and limit crosswalks. This lot and its adjacent pedestrian walkways will be reconstructed and reconfigured to meet the singular access point and maintain full accessibility of the parking lot.
