State of Iowa Executive Council:

On 11-26-25, Motorola personnel discovered a damaged radome on the Cedar Rapids ISCS tower. This damage was caused by severe storms in the area.

Motorola Warranty Representative Dave Gordon was able to provide the DPS Interoperability Communications Bureau an estimate of \$9,800 for repairs to the tower. Repairs will commence once a tower crew becomes available.

The DPS Interoperability Communications Bureau is respectfully submitting a 29C.20 allocation request for \$9,800 regarding this act of nature damage.
