When that deer passed I began to accelerate again when another deer ran into the driver side door of my patrol car. It broke the spot light off and caused damage to the driver side front fender, front door and rear door. The vehicle was still drivable and taken to Post 13. The mileage on my patrol vehicle at the time of the accident was 95,578.
